- Improvements and programs that provide new opportunities for our residents

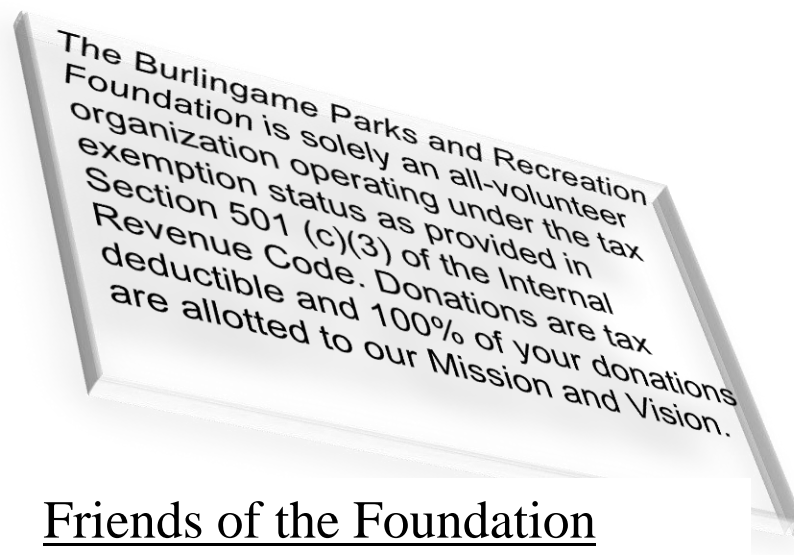


2016's Major Accomplishments & Fundraising Projects

- Donated \$5,000 for low-income Burlingame youth to participate in recreation programs. We helped 40 families enroll their children in recreation programs.
- Donated agility equipment for the Dog Park. Active dogs are healthy dogs with happy owners.
- Developed a new Foundation website and Facebook page to inform our community about the Foundation and our fundraising efforts.
- Pledged \$2,000 to the Burlingame Youth Baseball Association's project to renovate the dugouts at Bayside Park.
- Conducted a Bocce Tournament in Washington Park in May. Teams of residents and employees from Burlingame based companies competed in this fun event.
- Provided beverage and snack sales at the City's five Music in the Park concerts. These concerts are well attended and the concert patrons appreciate our services.
- Provided beverage and snack sales at the City's Movie's in the Park events, including the Family Overnighter and Throwback Thursdays. Movies were held at Washington Park, Village Park and Cuernavaca Park.
- Wine sales at the Fall Festival on Howard Avenue.
- Hot chocolate and apple cider sales at the Holiday Tree Lighting ceremony.

Major Goals for 2017

- Assist City events, such as Music in the Park concerts, Movies in the Park, and the annual Holiday Tree Lighting Ceremony
- Donate \$5,000 to the youth scholarship fund
- Financial assistance for the rebuilding of Paloma Park playground
- Mapping of Mills Canyon and publication of trail map
- Participate in the annual Bayfront clean-up
- Conduct a new Visits from Santa program
- Participate in the Howard Avenue Fall Festival
- Conduct a bocce tournament
- Offer new programs for the public, such as a Naturalist Kayak trip, Computer Security class, and Home Painting Tips
